SUBMISSIONS

Submissions were not received during the public notification period of this application.

REASONS FOR THE DECISION

Weipa Town Authority approved in full with conditions the application as it complied with the applicable assessment benchmarks. In particular:

The ADP's intent to avoid retail development in the Open Space Preferred Dominant Land Use Area is reflected in the table of assessment, prescribing a Shop as being 'Conflicting Development'; however, the 'Conflicting Development' definition provides scope for Weipa Town Authority to approve 'Conflicting Development' in the following circumstances:

- The proposal is relatively minor in scale;
- The previous use of the site; and
- The use is of an unusual character.

It is reasonable to approve the development, despite not complying with all provisions of the ADP (i.e. section 2.2 and 5.6), as it is demonstrated that it complies with the principal aim of the ADP, contained in section 2.1

To encourage and facilitate the proper use and management of the resources of the Town of Weipa and to ensure that development and re-development occurs in a manner which will most effectively promote health, safety and convenience and the economic, cultural, environmental and general welfare of the community and the amenity of every part of the town.

Weipa Town Authority in full with conditions the application despite the non-compliance the ADP as:

- 1. The scale of the proposal is limited to 80m2;
- 2. The use is commensurate with the use of the existing Weipa Bowls club and does not remove or detract from the open space/sport and recreation functions provided on site;
- 3. Will not have a detrimental external impact on the settlement pattern of the town or residential amenity nearby;
- 4. Conditions are imposed that are reasonable and relevant to the control of the use within its context.
